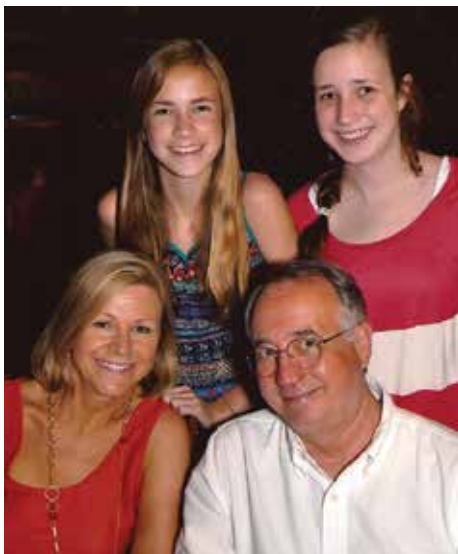

Richard Goodroe Enjoys a Blast from the Past with his Jukebox Restoration Hobby

Richard Goodroe, 2017 Hinman Trustees chairman, can shake, rattle and roll to the tunes of his collection of 1950's and 1960's jukeboxes. His hobby began in 1991 when he and his wife finished their basement as a 1950's diner, and he just had to have a jukebox to complete the look. He found one that was not working and fixed it up. These days, he keeps around 15 jukeboxes in his collection, simply because he doesn't have room for more. His favorite brands of jukeboxes are Wurlitzer and Seeburg. He likes the boxes that play 45 rpm records best, although he has three CD jukeboxes, as well. The second jukebox



he purchased was a 1959 Wurlitzer 200 selection machine. It was in such rough shape that his wife told him to take it to the dump. He refinished it and it is pictured to the left.

In addition to restoring jukeboxes, Dr. Goodroe also collects and restores pinball machines, automobile clocks and Ford and Thunderbird automobiles.

Third-Generation Dentist & North Dakota Native, Dr. Kathleen Robinson, Named Hinman Dental Society President

To say Dr. Kate Robinson is busy is an understatement, but somehow, she seems to juggle it all. When she's not practicing dentistry at Vassey Dental Partners, in Peachtree City, where she's practiced since 1990, she's tackling home decorating, participating in Jazzercise a few times a week and attending a two-hour Toastmasters meeting every Saturday morning. At one point, feeling particularly optimistic, she even attempted to learn the bagpipes. Unfortunately, her love for Scottish pipe and drum music wasn't enough to overcome how "ridiculously difficult it is to learn despite only having nine notes." (If anyone is interested in a slightly used set of bagpipes, give her a call!)

A native of Bismarck, North Dakota, Dr. Robinson is a third-generation dentist who followed in her father's footsteps. Her family moved to Atlanta in 1969 when her father, William Lauer, became a professor at Emory University School of Dentistry. Dr. Robinson earned her bachelor's degree in dental hygiene from the Medical College of Georgia and practiced dental hygiene for five years. Her mentor and employer, Dr. Marian Sprinkle, who was one of the first female dentists to practice in Atlanta, encouraged her to go to dental school. She also demonstrated how great it is to take care of people and connect with them on a personal level.

Dr. Robinson graduated from the Medical College of Georgia School of Dentistry with her D.M.D. in 1990 and has never looked

back. "I've been lucky enough to treat four generations of patient's families," she said. "Nothing is more satisfying than having my 'grown up' young patients come back to me as adults, bringing their spouses and children to me for dental care."

There was a time when she was a teenager when she thought she might become a concert promoter – the first female Alex Cooley. She had a lot of friends in the music business, but saw the more unsavory side of the business and is glad that her dad steered her toward dentistry. It was Drs. Chip Mohme, Bruce Ashendorf, Allen French and Jim Roos of MCG's Class of 1981 who helped her find Hinman. In the early 1990s, she worked with Dr. Dale Evans in the Pre-Registration booth, where he proclaimed, "Hey, you know EVERYBODY!" She loved chatting with people from her hygiene days, as well as classmates from her class and her husband Robby's class. "I thought it was a blast – I was hooked."

In addition to serving in many volunteer and executive council roles at Hinman, Dr. Robinson is a member of the International College of Dentists, Pierre Fauchard Academy, the American College of Dentists, and the Georgia Academy of Dental Practice. Her passion for dentistry is clear. "I love that dentistry is a combination of art, science and lots of psychology."

As President of the Hinman Dental Society, Dr. Robinson's goal is to represent and serve the members of the Society to the best of her ability. She also wants to support Dr. Yancey in every way possible to ensure that Hinman 2018 is the best dental meeting in the country. "It is the desire of all of the leadership in Hinman to build and nurture a membership that is actively involved in our Society."

With the help of her program chairman, she has planned several membership meetings over the next year featuring quality CE at nice venues for a reasonable cost, thanks to the Trustees. The year will culminate with the Annual Meeting held in June 2018 at Wild Dunes on the Isle of Palms, South Carolina. As a scout, Dr. Robinson has travelled to many other dental meetings, but always hears the same thing. "All the speakers can't wait to tell you how great Hinman is and how it really is the best dental meeting in the country. It makes me feel so proud to be a part of this meeting and it underscores how important everyone's role is at the March meeting."

She looks forward to Hinman 2018 when she can celebrate a year of accomplishments with Hinman members, the attendees and her family – husband Robby and daughters, Mary and Kimberly.

He and his wife, Mary, also enjoy flying over the North Georgia Mountains in the fall and seeing the colors of the changing leaves.
